Responsibilities and Duties

You will administer the Eclipse Foundation's Intellectual Property Due Diligence Review Process including:

- Engagement with open source software developers via a combination of public and private channels;
- Performing due diligence reviews of inbound software contributions ensuring developers adhere to policies and guidelines;
- Conducting investigative research to resolve non-compliance issues; while analyzing information, cross checking and validating information;
- Creating and maintaining well-documented records of provenance and analysis findings including detailed data to substantiate final review findings.
- Reviewing contributions to open source projects to:
 - Validate license compatibility and veracity;
 - Investigate and validate provenance; and
 - Identify intellectual property issues and work with developers to mitigate associated risk.
- Validating, administering, and oversight of legal paperwork required for Eclipse committers; and

- Being a designated resource internally and to the greater Eclipse community regarding the Eclipse Foundation's Intellectual Property process, policies, and practices.

- Knowledge and experience in using reporting tools for IP management and analysis processes;
- Experience working within a global environment;
