Minutes

- Lock down agenda and minutes of prior meeting 48 hours before the meeting.
- Approve of Minutes of February 18, 2021
 - Approved
- Adoptium Labs Project
 - Tim Ellison Project to house code that isn't directly related to the Adoptium project.
 - JLink.online is a suitable candidate.
 - Proposal is to create a separate project where ideas can be trialled. They may move if successful later on.
 - Sanhong: Similar to OpenJDK sandbox. Not supported for JDK11 or JDK8
 - George Adams: Which GitHub org would they reside in? Not sure yet.
 - Shelley Lambert thinks a separate sub project makes sense. We need to keep experimental work separate from Temurin.
 - No objections. Tim to work with Sanhong to define a new project.
 - Paul suggested a sub-committee in the long term.
- Working Group Charter Version 0.8 Approval
 - Tim Ellison put forward motion to approve
 - George Adams seconded
 - With no objections raised, the charter was approved, and version 0.8 will also be named 1.0 to reflect this milestone.
 - Thanks were given to all those involved in achieving the 1.0 milestone. Tim

 the project matures to reflect the objectives of the working group.
