Conditions for Participation at Open Source Park, CeBIT Hanover 2011

1. Open Source Park

Pluspol GmbH is organizing the joint exhibition stand Open Source Park from 1 to 5 March 2011. Within the framework of this concept the exhibitor presents its individual Open Source range of services. The contracting partner is sole exhibitor. Subleasing of the stand space to a third party is prohibited.

2. Exhibitor status

Prerequisite for the validity of the contract is the consent of the Deutsche Messe AG to the exhibitor's registration to CeBIT 2011. The participating companies will be entered as exhibitors and shall have all rights and obligations of an exhibitor at CeBIT 2011 in conformance with the Conditions of Participation of Deutsche Messe AG. These Conditions of Participation shall – unless explicitly agreed otherwise – be an integral part of the contract. The same applies to the other Conditions of Participation at the event, which will be forwarded to the exhibitor prior to the start of the Trade Fair. In addition to the generally available services, the exhibitor will receive a service package containing further special information and support for participation in the Open Source Park.

3. Conditions

The prices stated on the reverse side comprise stand rentals, basic stand equipment including erection and dismantling, together with a share of the costs for common areas and services as per the organizer's specifications. The exhibitor shall not be entitled to a specific shape/position of stand or floor space. Variations in the actual stand space of no more than 5% from the agreed size and the existence of pillars or electrical distributors thereon shall have no effect on the agreed price.

4. Basic equipment

The individual stand spaces have basic equipment consisting of floor covering, wall elements, graphic flags, fascia board with logo and company name, basic illumination and standard furnishing (presentation table, seating, etc.) without hardware and software. The templates for the fascia board must be submitted to the organizers by no later than 31 December 2010.

Special/additional equipment is available at an extra charge. A protected power supply of 2.5 kW is available at the individual stand spaces. The installation and use of electrical equipment, with the exception of exhibits, requires the express consent of the organizer.

5. Joint facilities

The common service areas are available to all exhibitors and their guests. Central storage and conference rooms can be used pro rata by arrangement free of charge.

6. Services

The following services are available free of charge: support for exhibition staff, electricity, normal exhibition surveillance, stand cleaning. The service package does not include insurance cover. The exhibitor shall be responsible for insuring his own exhibits.

7. Exhibitor media fee

The exhibitor may choose to be included in the product group catalogue in four product groups according to his range of products and services. This service is included in the exhibitor media fee. Any additional services must be arranged by the exhibitor directly with Deutsche Messe AG and will be charged accordingly. The exhibitor media fee shall also be payable if entry in the alphabetical exhibitor and/or product group catalogue is no longer possible due to belated registration of the exhibitor.

8. Exhibits

The exhibits must be delivered to the exhibition stand carriage paid by the exhibitor, set up according to the organizer's plans and dismantled and removed at the end of the exhibition. The fittings, equipment and operation of the leased stand space must conform to the general appearance of the event. The exhibitor's own graphics, additional company lettering and signage or affixed exhibits must be coordinated with the organizer prior to the exhibition and written approval obtained.

9. Implementation

Pluspol GmbH assumes responsibility for all work required for the planning and implementation of the event. Upon conclusion of the planning work the exhibitor will be informed of the location of his exhibition space, as well as delivery and pick-up of the exhibits. Exhibitor badges will be supplied to the exhibitors by Deutsche Messe AG free of charge.

Within the scope of his participation in Open Source Park the exhibitor shall show consideration to other exhibitors and safeguard the legitimate interests of third parties. All stand tenants shall have the same rights and obligations. In the event of dispute they will comply with the binding decision of the organizer. Breach of the obligation of consideration or contravention of the organizer's decision shall entitle the organizer to cancel the contract for compelling reasons. The exhibitor shall provide at least one qualified employee to be present at the erection of the stand at least one day before the start of the exhibition and familiarize him/herself with the premises. The employee must be an authorized representative for all questions related to this contract. The exhibitor shall occupy and maintain his exhibition stand for the duration of the event (Item 1).

10. Terms of payment

The exhibitor's fee is payable in three equal instalments: the first instalment shall be due within 30 days of the date of registration, the second on 1 December 2010 and the third instalment on 31 January 2011. For contracts concluded after 1 November 2010 the entire exhibitor fee shall be due within 14 days of contract signing. All payments must be made by the convenient direct debiting procedure. Payments for any additional services requested will be invoiced at the end of the event. Pluspol GmbH shall have a unilateral right of cancellation within four weeks of receipt of the signed contract in the case of negative credit assessment and the credit insurer refuses to insure the exhibitor.

After 1 January 2011 a rescission or ordinary cancellation of the contract shall be excluded. In the event that Pluspol GmbH is entitled to compensation for non-fulfilment, these shall be agreed at a flat rate of 30% of the total fee. The parties shall retain the right to demonstrate higher or substantially lower damages. The organizer has a duty vis-à-vis Deutsche Messe AG to use the entire leased floor space for exhibition purposes. Should an exhibitor fail to exhibit on the space leased by him in breach of his contractual obligations, he shall remain bound to pay the amount due under contract. In the event that the organizer is able to use the space for another purpose, the exhibitor shall be liable to pay a contractual penalty of 30% of the due fee. In addition to the contractual penalty the organizer shall be entitled to claim further compensation. If compensation in addition to the contractual penalty is claimed, the organizer shall offset the contractual penalty against the compensation.

11. Disclaimer, exhibitor's rights, written form, legal venue

Pluspol GmbH shall be liable for all contractual and non-contractual damage caused by it as a result of gross negligence or intent. In the event of an essential breach of contract Pluspol GmbH shall also be liable for slight negligence. Liability in this case shall be limited to damages which were reasonably foreseeable at the conclusion of the contract. Liability under mandatory statutory provisions, contractual agreement or warranty or due to personal damage and its consequences shall remain unaffected. Liability for damage incurred to an exhibitor due to delayed performance in the case of minor infringement shall be limited to 5% of the compensation. Information pertaining to the proposed exhibition site shall not substantiate any right to the retention and use of this location. In the event that CeBIT 2011 is cancelled as a whole, Pluspol GmbH shall be released from all obligations arising from this contractual relationship. All claims made by the exhibitor against the organizer must be submitted in writing. They shall be subject to a limitation period of six months after the close of CeBIT 2011. The exhibitor may only set off undisputed or legally founded claims. Agreements diverging from these conditions or supplementary regulations shall not be valid unless submitted in writing.

This contract shall be governed by German law to the exclusion of the UN Sales Convention. Insofar as the exhibitor is a merchant, the exclusive court of jurisdiction shall be Koblenz.
