Dan: After discussion, we decided to postpone the vote to add Participant member seats to the Committees. The options discussed were to add 1 or 2 seats. It was pointed out that Strategic members may lose a supermajority number of seats with the addition of Participant seats.

Discuss upcoming additional revisions to the WG Charter

Suggestion by Kai to change the WG charter so that new (non-founding) Strategic members do not need to make a 3 year commitment for membership. Paul White responded to the mailing list that the Eclipse Foundation was open to such a change.

ACTION: Sharon will propose a charter modification for the Steering Committee to consider for future approval.
